

**RESOLUTION NO. 06-11**

**A RESOLUTION REVISING WASTEWATER RATES AND RESCINDING RESOLUTION NO. 02-18.**

**WHEREAS,** the purpose of this Resolution is to implement the provisions of Scappoose Municipal Code 13.16.100 and 13.20.080 pertaining to payment of sewer rates and charges, and

**WHEREAS,** the City Council has completed a Sewer Rate Study to determine user rates; and

**WHEREAS,** the Capital Improvements Committee has held a public hearing on the proposed user rates and has made a recommendation to the City Council;

**NOW THEREFORE BE IT RESOLVED,**

**Section 1.** Basic residential sewer service shall be paid at the rate of \$30.205 per month per unit, plus 5 cents per 100 gallons of water used in excess of 4,000 gallons up to 10,000 gallons.

**Section 2.** Residential sewer users with no water service shall pay \$33.00 per month per unit.

**Section 3.** The City Council hereby adopts the City of Scappoose, Public Works Department, Standard Industrial Codes Catalog (SIC), by reference, and attached as Schedule A, as the means by which all monthly commercial and industrial sewer user rates will be charged.

**Section 4.** Resolution No. 02-18 is hereby rescinded effective July 21, 2006


**Section 5.** The rates adopted above shall take effect on and after July 21, 2006
