## Approval of the Agenda

## **Public Comments**

The reason he is here is not only to introduce himself but he recognizes that all politics is local and he appreciates the work that City Council's all over the Districts do for the local communities and in order for him to be a proper representative some day, hopefully beginning of next year, he thinks he needs to know a little bit more about the issues that people in this District are facing and so one way that he is doing this is visit every City Council in the District as much as he can. He thanked Council for their service. He explained he will be sitting in the back listening and

hopefully learning quite a bit about the issues that Scappoose faces and to see if there is some where down the road an opportunity for a Federal Candidate to be of some assistance for Scappoose. Council thanked him for being present.

## **Scappoose Boosters Event July 2011**

City Manager Hanken explained at the last City Council meeting there was a community forum regarding the Scappoose Boosters proposed community celebration in Veterans Park in July of 2011. City Council wanted to bring this back to do a formal motion to approve the location of the community event.

Councilor Gedlich moved and Council President Bernhard seconded the motion that the Scappoose City Council approve the Scappoose Boosters request to hold a community event in Veterans Park in July of 2011.

Council President Bernhard stated he looks forward to the Scappoose Booster hosting this event in a positive way that it is good for the whole community. He thanked the Boosters for bringing this to the City Council.

Councilor Gedlich thanked the Scappoose Boosters for all their work.

Councilor Heerwagen asked if there has been any progress on changing the name.

Michael Klobes, Scappoose Boosters, replied they have had some discussion but no decisions have been made.

Motion passed 6-0. Mayor Burge, aye; Council President Bernhard, aye; Councilor Gedlich, aye; Councilor Meres, aye: Councilor Heerwagen, aye and Councilor Erickson, aye.

## **Presentation on Columbia County Rider**

Janet Wright and Henry Heimuller are here this evening to give an overview and an update on the Columbia County Rider public transportation in Columbia County. They showed Council and staff some drawings on the proposed transit center. Janet Wright explained the funding for the transit

center has come from Connect 2 (2 million dollars) and the rest of it is State dollars. She explained there is no County dollars being put in to this; this is all grant funded monies.

Councilor Gedlich asked Janet Wright why Columbia County Rider requests \$20,000.00 from the City of Scappoose.

Janet Wright replied the reason she sends out her yearly letter looking for contributions is because the money that they get for operating the system is used to leverage State and Federal dollars and the more they can get the more dollars they can leverage.

Councilor Gedlich asked if part of the \$20,000.00 is for bus stops and or shelters.

Janet Wright replied it is used for a combination of things; the routes, the stops, the clean up and maintenance, the buses, the maintenances of the buses, the drivers, it goes for a multitude of types of transit services for people in the Scappoose School District (area they provide services to).

Henry Heimuller explained their park and ride at Grocery Outlet is private property and the owners of Grocery Outlet haven't wanted Columbia County Rider to have bus shelters on their lot. He stated it is the same thing on the ODOT property. He explained they are about ready to lose their park and ride at Grocery Outlet and their long term goal is to create a park and ride that belongs to Columbia County.

Janet Wright explained one of the things Columbia County Rider needs to do is actually find a site in Scappoose so what she is looking to do is write a grant or find some money to actually do a public process for sighting a park and ride in Scappoose. The City of Scappoose is last one who doesn't have an actual park and ride or transit center in their community that people can actually find and not have a problem using and parking.

Council President Bernhard asked about the percentage of riders in Scappoose.

Henry Heimuller replied they don't have those numbers with them. He explained there are any where from 50 to 70 cars a day parked at the two park and rides.

Council President Bernhard replied the reason he asked that question was because there was a comment made before the meeting on how a well thought out transit plan will also enhance or contribute dramatically to economic development and he totally agrees with that statement 100%. He stated as we continue to move forward, especially when it comes to transit portion of this, he thinks it is imperative that we have that type of data and that information so when we look at these things as a budgetary standpoint we have that information available and we can start looking at this, instead of it being a nonprofit type funding piece, we actually look at this as maybe we can start looking at from an annul reoccurring funding piece instead.

City Manager Hanken explained one of the things he wants everybody to consider is as we move forward with the Urban Growth Boundary expansion one of the things that we are going to need to do is a transportation plan update and part as our transportation master plan update we need to take in to consideration public transportation. He explained there is an opportunity here that he thinks

that is starting to immerge where in our process related to doing the transportation plan update and the public input process working with the transit to combine that effort.

Council President Bernhard stated he would like to request at this time that City Manager Hanken have conversation with Columbia County in terms of the amount of rides that are coming out of this area and that he come back to Council with some type of dollar figure that we need to be considering to help enhance the transportation issue that we have here in Scappoose. He stated not based on contributions made by other cities in the County but based on the needs on the riders in our community and based on the needs of our citizenship.

#### **New Business**

# Resolution No. 10-16: A Resolution Adopting a Supplemental Budget, Establishing Appropriations within the 2010-2011 Budget. (Foot Path & Bicycle Trails)

City Manager Hanken went over the staff report. He explained as stated at our July 19<sup>th</sup> Council meeting, engineering and construction costs for the High School Way sidewalk project was higher than expected. Council approved the contract with R & R General Contractors, Inc. (\$18,780) for the City's portion of construction. ODOT Rail Division has agreed to pay up to \$15,000 for the new railroad crossing panels to be installed by Portland & Western Railroad. Staff is asking Council to transfer \$20,000 from the fund's contingency line item to Council approved projects.

Council President Bernhard moved and Councilor Gedlich seconded the motion to approve Resolution No. 10-16: A Resolution Adopting a Supplemental Budget, Establishing Appropriations within the 2010-2011 Budget. (Foot Path & Bicycle Trails). Motion passed 6-0. ## IGA with ODOT Rail for High School Way Sidewalk Project

City Manager Hanken went over the staff report. He explained ODOT Rail Division has agreed to pay up to \$15,000 for the Portland & Western Railroad work to install the crossing panels. Total cost of the rail panel project is \$39,000. The City is responsible to pay P & W Railroad \$24,000. Staff asked for permission to enter into this IGA so the City could execute the agreement as soon as possible. Staff's goal is to have the crossing work completed by Friday, September 3<sup>rd</sup> so as not to have any conflicts when school starts on September 7<sup>th</sup>.

Councilor Gedlich moved and Council President Bernhard seconded the motion that City Council approve an IGA with ODOT Rail for High School Way Sidewalk Project. Motion passed 6-0.

Ordinance No. 812: An Ordinance Modifying Scappoose Municipal Code Chapter 12.16 Municipal Parks

City Manager Hanken went over the staff report. He explained Council has committed to allowing an off-leash area in Veterans Park (north of the intermittent stream). However to formally allow this, Council needs to modify their ordinance related to dogs in the City parks. Currently the code states that dogs have to be on leashes at all times. Staff is proposing that the code state: "No animals are permitted in municipal park unless they are on a leash, **except in designated off leash areas...**" This proposed change, along with signage in the park, would clearly mark where it is acceptable to have a dog off-leash.

Mayor Burge opened the public hearing at 7:48 p.m.

City Recorder Susan Reeves explained Jill Schull wanted to be here tonight but couldn't.

City Manager Hanken replied Jill Schull would have spoke in favor of it.

Mayor Burge closed the public hearing at 7:50 p.m.

Council President Bernhard moved and Councilor Erickson seconded the motion that City Council approve Ordinance No. 812: An Ordinance Modifying Scappoose Municipal Code Chapter 12.16 Municipal Parks as presented.

Mayor Burge read the title for the first time.

## Resolution No. 10-17: A Resolution of the City of Scappoose Approving the Purchase of Real Property and Approving the Financing for the Purchase of Real Property

City Manager Hanken went over Resolution No. 10-17 Approving the Purchase of Real Property and Approving the Financing for the Purchase of Real Property. He explained this is the 2.5 areas approximately that will be at the SE 2<sup>nd</sup> Street where Havlik will connect.
